The Weld County Council met in regular session in full conformity with the Weld County Home Rule Charter at 6:30 p.m., Monday, January 16, 2023, at the Weld County Administration Building, 1150 O Street, Greeley, CO.

**ROLL CALL:**

The meeting was called to order by President Nancy Teksten. Councilmembers Cindy Beemer, James Welch, Rupert Parchment and Elijah Hatch were present, constituting a quorum of members. Also present was Council Secretary Linda Kane.

Councilmember Parchment made a motion to honor MLK Day as a holiday and to no longer hold council meetings on that day, it was seconded by Councilmember Hatch and carried.

**Setting January meeting dates**

Councilmember Hatch made a motion that January meeting dates be set the previous December, it was seconded by Councilmember Welch and carried.


As an item of discussion, Councilmember Beemer said she'd like Council to discuss a better process for setting salaries for elected officials. Council agreed to discuss it further.
